To ensure the overall success of our behavior-based energy conservation program, the following areas will be emphasized:

1. A designated school district **Energy Manager** will be accountable for energy conservation on school district property ~~with Energy Education Specialist teams conducting energy audits and providing timely feedback.~~
2. All personnel at all school district buildings are expected to make a positive contribution to maximize energy conservation and produce real energy savings.
3. ~~Energy Education, Inc., will implement its energy conservation program primarily through an energy management team led by the Energy Education Specialist(s) in accordance with “Energy Guidelines” that will be adopted by the School Board of Trustees and administration and will define the “rules of engagement” for our energy program.~~
4. Accurate records of energy consumption and cost will be maintained by the Energy **Manager** ~~Education Specialist~~ for each school district building to provide verifiable performance results on the goals and progress of the energy conservation program.

Further, to promote a safe, healthy learning environment and to complement the energy conservation program, each school building shall review and adhere to the preventive

30 maintenance and monitoring plan administered by the school district physical **plant for its facilities**
31 **and systems, including HVAC, building envelope, and moisture management.**






