**Food Service Management Contract**

The Mountain Home School District No. 193, Mountain Home, Idaho, will accept written food service proposals from qualified food service management companies (FSMC) to provide food services to elementary and secondary students according to District specifications. The proposal for the **Food Service Management Contract** will commence on July 1, 2019, and include five renewable one-year terms, to be fulfilled June 30, 2024.

All proposals must be in a sealed container clearly marked "Food Service Bid Proposal." All proposals must be received by Levi Vick, at the School District Administration Office located at 470 North 3<sup>rd</sup> East, Mountain Home, Idaho, 83647, **no later than 2:00 p.m., Thursday, February 21, 2019.**

Bids will be opened at the above stated place and read aloud following the closing time for receipt of bids. Proposals received after scheduled closing will not be considered.

**A mandatory pre-bid tour will be held at 3:00 p.m., Friday, February 1, 2019**, at the School District Administration Office located at 470 North 3<sup>rd</sup> East, Mountain Home, Idaho, 83647. Each FSMC is limited to a maximum of two representatives. Attendance at the mandatory pre-bid tour is required if you wish to submit a proposal. The purpose of this conference is to answer questions related to our food service program and tour selected designated sites.

The winning bidder will be notified after Board approval, which is scheduled for March 19, 2019.

No Bid may be withdrawn or altered after the scheduled time for receipt of bids unless the award of contract is delayed for a period exceeding forty-five (45) days. All costs associated with the bid proposal shall be the sole cost of the bidder regardless of the outcome of their bid proposal.

The successful contractor must comply with all Federal and State safety and employment practices. These include but are not limited to the: National School Lunch Program (NSLP), School Breakfast Program (SBP), Occupational Safety and Health Administration (OSHA), Civil Rights Act of 1964, Equal Employment Opportunity Act, Clean Air Act, Clean Water Act, and the Environmental Protection Agency. The contractor shall assure to the District, in writing, they do not discriminate against any individual, employee, or applicant based on age, race, religion, creed, sex, national origin, or handicap.
