<u>TITLE I POLICY 4 – PARENT & FAMILY INVOLVEMENT/ENGAGEMENT – DISTRICTWIDE</u>

STATEMENT OF PURPOSE

The Mountain Home School District No. 193 (MHSD) is committed to the goal of offering a quality education to each student that has value and meaning. We believe that all students can achieve academic success and grow to be productive citizens. Partnerships with parents, family, and the community will assist our Title I schools in meeting these goals. Effective schools are a result of families and schools working together to promote high student achievement.

Our Title I schools will involve parents and families in regular, two-way meaningful communication addressing student achievement and ensuring:

- Parents play an integral role in assisting with their child's academic and social emotional growth.
- Parents and family are full partners in their child's education and are included, as appropriate, in decision-making, and on advisory committees to assist in the education of their child.

PART 1. GENERAL EXPECTATIONS

Mountain Home School Board of Trustees has set expectations for our parent and family involvement and engagement through an organized and systematic approach to encourage parent and family participation in the education process for their children. Our expectations include having the District and Title I schools conduct at least an annual meeting with parents of Title I students and comply with all requirements of section 1118(d) of the ESEA, and that of the ESSA and Title I policies to create the named partnerships and compact. (Section 1118(a)(2)(b)(d) ESEA, and that of the ESSA)

Mountain Home School District No. 193 agrees to implement the following statutory requirements:

- Mountain Home School District will involve the parents of children served in Title I, Part A schools, in decisions about how the one (1%) percent of Title I, Part A funds reserved for parent involvement is spent, and will ensure that not less than ninety-five (95%) percent of the one percent reserved goes directly to the schools.

 - * Title I schools will invite parents or parent representatives to be members on the schools' Leadership Teams, Parent Teams/Groups, etc., to assist with planning events, such as family involvement activities during the school days or at night, reviewing and revising their school's Parent & Family Involvement Building Procedures, and review yearly data.

- 2. MHSD will take the following actions to involve parents in the process of Title I school review and improvement under section 1116 of the ESEA, and that of the ESSA:
 - We invite parents and families to be members of our District Parent Team that meets once a semester to discuss, review, coordinate, strategize, etc., and how to best implement the Title I, Plan A programs into the school buildings.
 - ~ Parents and families will be involved in the development of our District's Title I Plan and the process of school review and improvement, and in providing coordination, technical assistance, and other support necessary to assist the Title I schools in planning and implementing parent and family involvement and engagement activities.  - ~ MHSD requires our Title I schools to follow similar actions so that they may include their parents and families with the school's involvement and engagement procedures and to encourage suggestions for parent/family activities.
 - MHSD schedules two Parent-Teacher Conferences, one in the fall and one in the winter.
 - MHSD encourages parents, families, and the community to fill out and submit Parent Input forms to keep the district and Title I schools aware of what areas of concern need to be addressed or what areas is the district and/or school meeting to the parent and community's satisfaction.
 - We support each of the Title I school buildings' Parent Leadership Teams and their proposals for activities, events, family nights, etc.
- 3. MHSD will provide the following necessary coordination, technical assistance, and other support to assist Title I, Part A schools in planning and implementing effective parent & family involvement/engagement activities to improve student academic achievement and school performance:
 - Title I schools will hold meetings to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the rights of parents to be involved in Title I, Part A programs.
 - MHSD, through our Title I schools, places their parent/family activities and events on their Facebook pages and on their building's calendar, which then flows into the Districtwide calendar to keep parents/families, and the community informed.
 - ~ Title I schools' families are informed of the activities through monthly newsletters, monthly calendars, monthly Home & School Connection Letters, reminder notes, emails, and events posted on the school and district's webpage.

- ~ Title I schools host a multitude of family activities such as Open House, Family Nights, Math Nights, and such.
- Information, suggestions, assistance, and support for the Title I, Part A plans are collective in nature and shared districtwide.
- If time allows and the availability of district resources, communications sent home will be in both English and Spanish.
- 4. MHSD will integrate and coordinate parent and family involvement and engagement strategies in Part A with Head Start, Reading First, Early Reading First, Even Start, Parents As Teachers, Home Instruction Program for Preschool Youngsters, and similar programs in the district.
 - The Title I Coordinator will regularly communicate with these programs and share parent and family input, and recommendations for their consideration.
- 5. The MHSD will take actions to conduct, with the involvement of parents, an annual evaluation of the content and effectiveness of this Parent Involvement Policy, in improving the quality of our Title I, Part A schools and focusing on its effectiveness in increasing parent & family involvement and identifying barriers to greater participation by parent & family involvement and engagement activities (with particular attention to parents who are economically disadvantaged, are disabled, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority background).
 - We invite parents and families to be members of our District Parent Team that meets once a semester to discuss, review, coordinate, strategize, etc., and how to best implement the Title I, Plan A programs into the school buildings.

- ~ Title I schools invite their families to attend the different events scheduled throughout the school year to keep parents informed on the school's expectations, curriculum, goals, assessment data, etc.
- Parent-Teacher Conferences are held once in the fall and once in the winter, but teachers are required to contact their student's parents as often as necessary to keep the parent informed of the student's progress both academically and socially/emotionally. Parent may also request additional conferences throughout the year.
- Newsletters and other means of communication containing district and Title I school information such as expectations, curriculum, goals, assessment data, etc., is shared with families in addition to posting information on the district and school's webpage and Facebook page.
- If time allows and with the availability of district resources, communications sent home will be in both English and Spanish.
- 6. MHSD will use the findings of the evaluation about our Parent & Family Involvement Policy and activities to design strategies for more effective parent involvement, and to revise, if necessary (and with the involvement of parents) our Parent & Family Involvement Policies using the collection of objective data regarding the number of parents attending meetings and requesting parent meetings with teachers or other staff, including administrators; the analysis of the issues or concerns raised by parents, and their resolution; and the level of parent satisfaction with the district's processes.
 - Based upon the evaluation results received from parent input, the district and individual Title I schools will revise this policy as determined to be necessary for more effective parent/family involvement/engagement. - 7. - Our district's Title I schools will hold an Open House for parents and families at the start of the school year, as well as parent/family involvement/engagement activities; hold meetings as necessary to keep parents informed; schedule parent conferences as needed outside of the two scheduled Parent-Teacher Conferences.
 - ~ During these times, Title I schools will inform parents and families on the school's expectations, achievement standards, state and local academic assessments including alternate assessments, the requirements of Part A, as well as curriculum, goals, assessment data, etc.
 - * Parents also have access to Parent Portal, PowerSchool, and both school and district websites and Facebook pages.
 - ~ MHSD holds two Parent-Teacher Conferences, one in the fall and one in the winter.
 - * During these times, parents and teachers meet to discuss student's progress both academically and socially/emotionally. Teachers and parents can also request additional conferences throughout the year.
- 8. MHSD will, with the assistance of our Title I schools, provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training, and using technology, as appropriate, to foster parent and family involvement, by:
 - Providing the Idaho Standards Achievement Test (ISAT) and all other federal, state, and school assessment data to our parents in a timely manner. Assessment description, expected outcomes, and scores are included in this information.
 - During conferences, parents and teachers meet to discuss their student's progress and receive ideas on how to support their student's learning. Teachers and parents can also request additional conferences throughout the year.
 - Our school district and our Title I schools sends home monthly Home & School Connections Newsletters, hosts family participation events, and communicates with parents about resources and technology they can use at home.
 - Our Title I schools keep parents aware of their student's progress, quarter and semester grades are made available to parents at conferences.
 - ~ Parents are given a PowerSchool username and password to access grades and attendance.

- ~ Grade reports are emailed home to those who don't attend.
- ~ Parent Portal and PowerSchool are available to parents 24/7
- Title I school staff is available to assist any parent with resources and technology they can use at home, specifically the use of PowerSchool.
- 9. MHSD will, with the assistance of our Title I schools and parents, educate our teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:
 - Professional Development opportunities are available to staff of Title I schools.
- 10. MHSD will, to the extent feasible and appropriate, coordinate and integrate parent & family involvement programs and activities with Head Start, Reading First, Early Reading First, Even Start, Home Instruction Programs for Preschool Youngsters, and public preschool and other programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children, by:
 - Our Title I Coordinator participates in yearly meetings with the Head Start staff parents, discussing Kindergarten expectations, standards, at home activities, etc.
 - Information is shared with other community programs, when requested.
- 11. Our school district will take the following actions to ensure that information related to the Title I school and parent-programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:
 - Our Title I school administration and teachers communicate with our parents in person, through email, phone calls, monthly newsletters, Principal Newsletter, and calendars.
 - Our Title I schools invite parents to conferences, open houses, future Advancement Via Individual Determination (AVID), and Positive Behavioral Interventions and Supports (PBIS) nights.
 - MHSD holds two Parent-Teacher Conferences, one in the fall and one in the winter.

- ~ During these times, parents and teachers meet to discuss student's progress both academically and socially/emotionally. Teachers and parents can also request additional conferences throughout the year.
- Parents are given a PowerSchool username and password to access grades and attendance, as well as contact teachers.
- When resources and time allows or is available, we provide Spanish-speaking staff members at both fall and winter conferences and throughout the school day to translate as needed.
- When resources and time allows or is available, communication sent home is in both English and Spanish.

- MHSD will pay reasonable and necessary expenses associated with Title I parent involvement activities, including transportation and child care costs, to enable parents to participate in school-related meetings and training sessions;
- MHSD, within reason, will train parents to enhance the involvement of other parents;
