

1 **TRUSTEE NOMINATION, ELECTION, & FINANCIAL REPORTING POLICY**

2
3 **NOMINATION OF TRUSTEES**

4
5 Any person legally qualified to hold the office of school trustee may file a declaration of candidacy
6 for the office. The declaration must bear the name of the candidate, state the term for which
7 declaration of candidacy is made, and bear the signature of not less than five (5) school district
8 electors resident of the trustee zone of which the candidate is resident. The declaration of
9 candidacy must be filed with the clerk of the board not later than five (5) o'clock p.m. on the ninth
10 (9th) Friday preceding the day of election of trustees. **The clerk of the board of trustees will**
11 **verify the qualifications of the nominees and shall, not more than seven (7) days following**
12 **the filing, certify the nominees to be placed on the ballot.**

13
14 Any person interested in being a write-in candidate for a school trustee position must file a
15 declaration of intent indicating that the person desires the trustee office and is legally qualified to
16 assume the duties of school trustee if elected. The declaration of intent for write-in candidates
17 must be filed with the county clerk not later than forty-five (45) days before the day of election.
18 No write-in vote will be counted unless a declaration of intent has been properly filed.

19
20 Any person who filed a declaration of candidacy may withdraw from the election by filing a
21 notarized statement of withdrawal with the county clerk. The notarized statement must contain all
22 the information necessary to identify the person and the office sought, and the reason for the
23 withdrawal. The candidate may not withdraw later than forty-five (45) days prior to the day of the
24 election. The board is prohibited from appointing any candidate who filed a statement of
25 withdrawal, unless the vacancy occurs because of the death of a previous candidate.

26
27 **ELECTION OF TRUSTEES**

29 If a district is located in one (1) county, the election of the trustees shall be conducted by the county
30 clerk in which the district is located, in compliance with Title 34, Idaho Code.

31
32 If the district is a joint district located in two (2) counties, the election of the trustees shall be
33 conducted by the county clerks of the respective counties in which the district is located, in
34 compliance with Title 34, Idaho Code.

35
36 If the date for filing written nominations for the office of trustees has expired, and it appears that
37 only one (1) qualified candidate has been nominated for a trustee position, or if only one (1)
38 candidate has filed a write-in declaration of intent **as provided in Idaho Code §34-1407, and the**
39 **candidate has provided to the district's board clerk the signatures of five (5) electors of the**
40 **candidate's specific zone, then** no election will be held for that position, and the board, or the
41 school district clerk with the written permission of the board, will declare such candidate elected
42 as trustee. A certificate of election bearing the seal of the district will be prepared by the school
43 district clerk and delivered to the person declared as elected.

44
45 Trustee elections will be held on the **Tuesday following the first Monday in November** ~~third~~
46 ~~(3rd) Tuesday in May~~ in odd-numbered years. In each trustee zone, the person receiving the
47 greatest number of votes cast in his or her trustee zone will be declared by the board as the trustee
48 elected from that trustee zone. The elected trustee will assume office on **January** ~~July~~ 1, next
49 following the election.

50
51 If any two (2) or more persons **residing in the same trustee zone** have an equal number of votes
52 ~~in any trustee zone~~ and a greater number than any other nominee **residing** in that trustee zone,
53 **then** the board will determine the winner by a toss of a coin.

54
55 **Effective July 1, 2018, the terms of incumbent trustees will expire on January 1 following the**
56 **November election of their successors.**

57
58 **TRUSTEE CANDIDATE REPORTING REQUIREMENTS**

60 In school districts with 500 or more students, the candidate disclosure and reporting requirements
61 of sections 67-6601 through 67-6616, Idaho Code, and sections 67-6623 through 67-6630, Idaho
62 Code shall apply to all elections of school district trustees. Any report or filing required to be filed
63 by or for a candidate shall be filed with the county clerk of the county wherein the district lies or,
64 in the case of a joint district, with the county clerk of the home county as designated pursuant to
65 section 33-304, Idaho Code.
