### **VETERAN'S PREFERENCE FORM**

## Idaho law provides veterans' preference for eligible veterans or eligible spouses who:

- Have been in active service in the armed forces of the United States for a minimum of one hundred eighty (180) consecutive days<sup>1</sup> and honorably discharged, OR
- Are disabled veterans who served on active duty in the armed forces and have a current service-connected disability of ten percent (10%) or more or are receiving compensation related to a service-connected disability including retirement benefits or pension from the military or the Department of Veteran Affairs, OR
- Are Purple Heart recipients, OR
- Are the widow or widower of an eligible veteran and have not remarried, OR
- Are the qualifying spouse of an eligible service-connected disabled veteran who cannot qualify for any public employment because of a service-connected disability.

Temporary or casual employment does not qualify as an "initial appointment.
