

SPECIAL BOARD MEETING – PUBLIC INPUT HEARING

A special meeting of the Board of Trustees of Mountain Home School District No. 193 was convened at 7:15 p.m., February 16, 2016, at the District Administration Office, 470 North 3<sup>rd</sup> East, Mountain Home, Idaho, in said district, pursuant to authority provided by Title 33 Chapter 5, Sections 33-506, 33-510, 33-512, Title 63, Chapter 13, Section 63-1311A, and Title 74, Chapter 2, Sections 74-202(4)(c)(6)(b) Open Public Meetings (Special Meeting), 74-203(5) Open Meeting (Telecommunication), and 74-204(2) Notice of Meetings, Idaho Code, and pursuant to affirmation by the Clerk that notice of the special meeting had been given to each trustee and posted public notice as required by law. **NOTICE OF PRICE INCREASE**

The Mountain Home School District No. 193, Elmore County, is required to increase the student meal price for all the schools in Mountain Home School District due to the Healthy Hunger Free Kids Act of 2010, as required by Federal Law, Public Law 111-296. School Lunches will increase every year until we meet the Federal Healthy Hunger Free Kids Act of 2010. The following table is what this change will mean to students.
