- VI. **REPORTS –**

- A. MOUNTAIN HOME AFB UPDATE** – MHAFB Liaison. Mr. Niksich notified the board that one of the new commanders, Colonel Richard Goodman, arrived. He has four children, one elementary, one middle school, one junior high, and one high school.

Mr. Niksich informed the board that the base had its biggest turnover ever in active duty personnel. He said that means there would be many new students in the schools and if teachers notice concerning behaviors to utilize the Military Family Life Counselors. The base will host an event to bring new together new students with students who have been here for at least a year, so they might find a friend before the first day of school.

Mr. Niksich reported that the base is preparing for the military affiliated Back To School Brigade

designed to provide backpacks and school supplies to military kids.

Mr. Niksich continued to report that the base has 25 volunteers to help with the HMS playground.

Superintendent Gilbert asked Mr. Niksich that with the huge turnover on the base, would there be more students. Mr. Niksich replied no, the fluctuation would remain the about same.

Mr. Niksich also reported that the base is hosting an active shooter sexercise on the base that would include base, local, federal, and state first responders. He added that the board, Superintendent Gilbert, and building principals and teachers were invited to go and observe the active shooter exercise.

Mr. Niksich informed the board that the "Warm Heart" Tournament starts Friday. He explained that Warm Heart is a continuous softball tournament, starting Friday evening and ending Sunday midday, between multiple teams such as base commanders vs base Chief Master Sergeants, squadrons vs squadrons, etc., and that teams from four other states are playing in the tournament. The tournament raises money for military families.

The board thanked Mr. Niksich.

- B. SUPERINTENDENT’S REPORT** – James Gilbert. Superintendent Gilbert reported that the district is still in the firing mode. He added that the district hit a few roadblocks with finding qualifying special education teacher candidates. Superintendent Gilbert continued to report that a school psychologist was hired who is a military spouse coming from out of state. He continued to report that as we get closer to August 1, we would start offering positions to people out of certification areas using the interim routes that the state makes available.

RESOLUTION FOR DELEGATING AUTHORITY TO SUSPEND STUDENTS**

WHEREAS, The Board of Trustees is granted the power to deny attendance to any pupil who is a habitual truant, or who is incorrigible, or whose conduct is such as to be continuously disruptive of school discipline, or of the instructional effectiveness of the school, or whose presence in a public school is detrimental to the health and safety of other pupils, by Idaho Code 33-205 and as defined by Idaho Code Section 33-206; and

WHEREAS, The Board is of the opinion that there may be times that it is in the best interest of the school district to allow administrative staff to take immediate action against a pupil who is habitually truant, or who is incorrigible, or whose conduct is such as to be continuously disruptive of school discipline, or of the instructional effectiveness of the school, or whose presence in a public school is detrimental to the health and safety of other pupils, without the necessity of first appearing before the Board of Trustees; and

WHEREAS, The Board desires to grant authority to certain school district administrators to suspend students and to bring notice of such action to the Board at the regularly scheduled meetings.

- C. **RESOLUTION 20-03 – CALLING FOR A TRUSTEE ELECTION – Zones 1, 3, & 5 (ACTION/ROLLCALL VOTE)** – James Gilbert. Superintendent Gilbert requested the adoption of this resolution to start the process for the trustee election on November 5, 2019, for Zone 1, Zone 3, and Zone 5. He then read the resolution aloud. Trustee Monasterio motioned for the adoption of Resolution 20-03 Calling for Trustee Election for Zones 1, 3, & 5, as presented by Superintendent Gilbert, with a second from Trustee Donahue. Roll call vote followed.

RESOLUTION 20-03 CALLING FOR A TRUSTEE ELECTION**

WHEREAS, in accordance with Title 33, Chapter 4, Section 33-401, Chapter 5, Section 33-503; Title 34, Section 34-106(1)(b)(8), Idaho Code, the Board of Trustees of Mountain Home School District No. 193 and the Elmore County Clerk (County Clerk) shall cause to be conducted its Trustee Election on the Tuesday following the first Monday in November off odd numbered years the purpose of electing a trustee for Trustee Zone-1 and electing a trustee for Trustee Zone-3 and electing a trustee for Trustee Zone-5.

WHEREAS, in accordance with Section 34-1407, Idaho Code, no write-in vote for school trustee shall be counted unless a declaration of intent has been filed indicating that the person desires the office and is legally qualified to assume the duties of school trustee if elected. Such declaration of intent shall be filed no later than forty-five (45) days before the day of election, and

WHEREAS, in accordance with Section 33-502B and 34-1407, Idaho Code, if after the date for filing written nominations for the office of trustee, it appears that only one (1) qualified candidate has been nominated, and if no declaration of intent has been filed as provided for by Section 34-1407, Idaho Code, no election shall be held for that position, and the County Election Clerk shall within forty-five (45) days before the scheduled date of the election declare such candidate elected as trustee, and

NOW, THEREFORE, be it resolved by the Board of Trustees of School District No. 193, Elmore County, as follows:

Section 1 That a Trustee Election is hereby called to be held in Mountain Home School District No. 193, Elmore County, Idaho, on November 5, 2019, for the purpose of electing a Trustee for Zone-1 and a Trustee for Zone-3 and a Trustee from Zone-5.

Idaho Code shall be fully applicable and shall govern all school elections. All school elections shall be administered by the Clerk of Elmore County wherein the district lies. That said election would be conducted by the County Clerk in accordance with Title 33, Section 33-401, Idaho Code, Title 34, Section 34-1401, Idaho Code.

Section 2 That on Tuesday, November 5, 2019, the polls shall be opened between the hours of 8:00 a.m. until 8:00 p.m. (I.C. 34-1409).

Section 3 That said election shall be held as specified in the Notice of Election, as published by the County Clerk in accordance with Title 34, Section 34-1406, Idaho Code, and set out in Section 9 herein.

Section 4 That said election shall be administered and conducted by the County Clerk of the county wherein the district lies and in accordance with Titles 33 and 34, Sections 33-401 and 34-1401, Idaho Code. The County Clerk shall appoint two (2) or more election judges, one (1) of whom shall be designated chief judge, and the number of clerks deemed necessary by the County Clerk for each polling place, in accordance with Title 34, Section 34-303, Idaho Code.

Section 5 That the polling places of said election should be established by the Elmore County Commissioners not less than 30-days before any election in accordance with Title 34, Section 34-302, Idaho Code, as follows:

Trustee Zone-1 and Trustee Zone-3 and Trustee Zone-5

Voters residing in Trustee Zone-1 and voters residing in Trustee Zone-3 and voters residing in Trustee Zone-5 will go to **their regular polling place**, in their respective trustee zone/precinct, as established by the County Commissioners.

Section 6 That no person shall vote at such trustee election who is not at the time of election (Titles 33 and 34, Sections 33-405, 34-107, 34-402, 34-403, 34-404, and 34-405, Idaho Code):

1. A United States citizen, a qualified elector of the state, county, and district, and qualified elector of the trustee zone for at least 30-days preceding the day of election, a registered voter in the District, and 18 years of age or older, within the meaning of Article 6, Section 2 of the Idaho Constitution; and
2. A registered elector governed by the provisions of title 34, Idaho Code.
3. A bona fide resident of the same trustee zone as the candidate for school trustee for whom the elector offers to vote.

Section 7 That voting at said election shall be by secret and separate ballot, and each ballot shall be prepared by the Clerk of the Board of Trustees and shall be submitted to the Elmore County Clerk, and shall be substantially in the following form:

Section 8

That immediately following the close of the polls, the judges must immediately proceed to count the ballots cast at such election. The counting must be continued without adjournment until completed and the result declared (I.C. 34-1201). The County Board of Commissioners shall be the County Board of Canvassers and the County Clerk shall serve as their secretary for this purpose. The County Board of Canvassers shall meet within ten (10) days after the election for the purpose of canvassing the election returns of all precincts within the county (I.C. 34-1205, 34-1206). The County Clerk shall certify the election results to the Clerk of each political subdivision for which an election was held. The person receiving the greatest number of votes cast within the Zone shall be declared by the MHSD Board of Trustees to be the trustee from that Zone (I.C. 34-1201 and 34-1410). Each political subdivision shall issue the appropriate certificates of election (I.C. 34-1410). Candidates for office elected in May shall take office on the date specified in the Certificate of Election, but not more than sixty (60) days following the election (I.C. 34-106(2)).

Section 9

That the County Clerk shall have published the Notice of Filing Deadline, which is similarly or substantially in the following form:
