CONTRACT FOR SPEECH/LANGUAGE SERVICES:

The Mountain Home School District, through the Special Education Department, "School", hereby contracts with Communicate Therapy Services, "Provider", to provide speech and language services on behalf of the Mountain Home School District for the 2014-2015 School Year.

School has students requiring speech and language services as part of its overall special education programs. Provider desires to contract with the School to offer such services to assigned schools.


THE PARTIES THEREFORE AGREE TO THE FOLLOWING TERMS:

1. Provider shall bill the School by the first Friday of each month for services provided the previous month.
2. School shall pay such bill on or before the 30th of the same month.
3. Provider shall provide a copy of malpractice insurance to the school and is responsible for her own Social Security and Income Tax withholdings, as she is not an employee of the School.
4. Provider shall render the following services:
 - a. Perform speech and language evaluations, as required by IDEA, to include observations if necessary.
 - b. Develop and implement Individual Education Programs for students who qualify for speech and/or language services, according to the Idaho Manual for Special Education, which may include direct individual or group therapy, consulting and/or monitoring of progress.
 - c. Confer with appropriate personnel about student services/needs.
 - d. Make recommendations regarding service delivery and the student's needs to the IEP team for team consensus.
 - e. Provider will attend meetings, such as IEP meetings and conferences, given adequate notice, as she is able.
 - f. Prepare and maintain appropriate professional records and reports for all students under Provider's care, which may include developing IEPs, progress reports, notes and data on students, and Medicaid billing requirements.
 - g. Provide consultation/training/supervision to staff regarding speech and language needs and programs of the students.
5. PROVIDER WILL COMPLY WITH ALL Federal, State and Local regulations concerning IDEA and maintenance of confidentiality.
6. School will provide access to required assessment and screening materials, district forms, duplicating services, a computer and computer software programs.
7. School shall pay Provider(s) 65.00 dollars per hour for each hour services are provided.
 - a. Services provided above 40 hours/week per SLP will be paid at an overtime rate of \$97.50 per hour per SLP.
 - b. Communicate Therapy Services will provide two (2) full-time Speech-Language Pathologists. District is actively seeking part-time Speech-Language Pathologist (20-25 hours per week) to provide services to the Mountain Home Junior High School and Mountain Home High School speech-language eligible students.


- c. Contract will be renegotiated if caseloads rise above 65 students (including current students under special education referral) consistently over one month. Numbers will be reviewed at the beginning of each month and Provider will submit current caseload number with monthly invoice.
- 8. School shall pay Provider 0.37 cents per mile traveled to work site.
- 9. Services will be provided following certified staff schedule including Teacher Workdays, Student Attendance Days, and Professional Learning Community Days.

THIS AGREEMENT SHALL BE INTERPRETED UNDER AND ACCORDING TO THE LAW AS OF THE STATE OF IDAHO.

I accept the terms set forth in this agreement and effective immediately upon execution of this agreement.
