Contractual Agreement

Consultant: KidAbilities PC Inc.

Client: Mountain Home School District

THE PARTIES THEREFORE AGREE TO THE FOLLOWING TERMS:

KidAbilities Inc. Agrees:

1. To provide Mountain Home School District with Occupational, Physical and Speech Therapy services supported by qualified, certified and licensed therapists.
2. To maintain our own liability/malpractice insurance.
3. To comply with all Federal, State and Local regulations and maintenance of confidentiality.
4. To maintain the necessary professional records as required by Mountain Home School District.
5. To render all occupational, physical and speech therapy services specified by Mountain Home School District.
6. To provide a monthly invoice based on a rate of \$60.00 per hour for OTR/L services, \$45.00 per hour for COTA/L provided Occupational Therapy services, \$65.00 per hour for PT services and \$50 per hour for PTA provided Physical Therapy services and \$65 per hour for SLP services, \$50 per hour for SLP assistant provided Speech and Language Therapy services.

Mountain Home School District Agrees:

1. The contractor, KidAbilities Inc. to be paid the rate of \$60.00 per hour for OTR/L, \$45.00 per hour for COTA/L provided Occupational Therapy services, \$65.00 per hour for PT services and \$50 per hour for PTA provided Physical Therapy services and \$65 per hour for SLP services and \$50 per hour for SLP assistant provided Speech Therapy services. Overtime rates will apply to work hours exceeding 40 per week.
2. To pay travel time to and from therapist's home (if residence is 20 miles and beyond) as well as mileage reimbursement of (.37 cents per mile) between site locations.
3. To provide equipment, assessment materials, computer and space in which services can be delivered in accordance with program philosophy.
4. To make records of clients available to professional occupational, physical and speech therapy staff members as necessary to provide services.
5. To allow KidAbilities Inc. to exclusively service all Occupational, Physical and Speech Therapy needs.

KidAbilities Inc. and Mountain Home School District Mutually Agree:

This contract shall become effective October 31st, 2016 and will continue as Occupational, Physical and Speech and Language Therapy services are needed by Mountain Home School District. Either party may terminate this agreement at will provided that a written notice of termination is given thirty (30) days in advance.

KidAbilities Inc. reserves the right to place a COTA/L, PTA or SLP assistant under the supervision of an OTR/L, PT or SLP to support and provide therapy to the Mountain Home School District. OTR/L, PT or SLP will monitor COTA/L, PTA and/or SLP assistant on a weekly basis, perform all assessments and develop treatment plans and goals for the COTA/L, PTA or SLP assistant to follow during therapy sessions. KidAbilities Inc. shall invoice Mountain Home School District by the 7th of each month for services provided the previous month. The school district shall pay each monthly invoice on or before the 30th of the same month.

Unforeseen questions or any problems whatsoever arising during the administration of the contract between parties shall be resolved through negotiations.

Neither the Mountain Home School District nor KidAbilities Inc. will employ or independently contract with employees' of the other organization during the duration of this contract and 6 months following the termination of this agreement.
